What information do we collect?

We collect information from you when registering using our software, fill out a form or interact with any of the Virtual Event features or AMS features.

When using the software, as appropriate, you may be asked to enter your: name, e-mail address, mailing address, phone number, credit card information, etc. as determined by the software's setup for each client's needs. You may, however, visit our site anonymously. Information will vary based on the client's installation of the software for their needs.

What do we use your information for?

Any of the information we collect from you may be used in one of the following ways:

How do we protect your information?

We implement a variety of security measures to maintain the safety of your personal information when you enter, submit, or access your personal information.

We offer the use of a secure server. All supplied sensitive/credit information is transmitted via Secure Socket Layer (SSL) technology and then encrypted into our Payment gateway providers database only to be accessible by those authorized with special access rights to such systems and are required to keep the information confidential.

After a financial transaction, your private information will not be stored on our servers.

Do we use cookies?

Yes, we use cookies. (Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser (if you allow) that enables the sites or service provider's systems to recognize your browser and capture and remember certain information.) We use cookies to help us track the login activity on Echodea's software.

Do we disclose any information to outside parties?

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information. This does not include trusted third parties who assist us in operating our website, software, conducting our business, or servicing you, so long as those parties agree to keep this information confidential. We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or others' rights, property, or safety.
